**Minutes of the 5<sup>th</sup> meeting of the EMG Consultative Process for the preparation of a System Wide- Framework of Strategies on the Environment**

**1. Introduction**

The fifth meeting of the Consultative Process took place in the form of a drafting workshop hosted by UNDP in New York from 15 to 17 December 2015. The meeting was co-chaired by Corli Pretorius, UNEP and Tim Scott, UNDP. The list of participants is provided in Annex I.

The workshop adopted its agenda and worked during three consecutive days to prepare an annotated outline for a Framework for Collaboration on the Environment in the UN system, taking into account earlier discussions and concept notes of the Consultative Process in the context of contributing to the implementation of the 2030 Agenda and responding to UNEA Resolution 1/11.

**2. Consideration of organisation of work, modalities and the expected outcome of the meeting**

Following an overview by the EMG Secretariat of the process to date, the co-chairs highlighted the role the SWFS can play to enhance synergies and coherence around implementing the 2030 Agenda for Sustainable Development and the SDGs. They saw the workshop as an opportunity to come to a common understanding of what the SWFS should aim to achieve and to agree on the logical framework as a basis for its implementation.

**Agreed Action**

The meeting agreed to proceed by considering the draft outline of the SWFS as one group rather than dividing the work among smaller working groups. The meeting should result in an annotated outline, based on which the co-chairs will prepare a first draft of the SWFS.

**3. Drafting of the SWFS based on the Concept Note of the SWFS and background**

Under the lead of the co-chairs, the meeting participants worked to annotate the outline, section by section.
