Mid-Term Progress Report

Note by the Secretariat

This note has been prepared to support the discussions of the midterm technical segment of the 27th Senior Officials Meeting by providing a short progress report on the work of the EMG Issue Management Groups and Consultative Processes, as well as the next steps of their work in line with the decisions taken by the 26th Senior Officials' Meeting in October 2021 . The Task Team has contributed to the preparation of the EMG Report on Marine Litter and Microplastics: "Assessment of UN Activities and Initiatives related to Marine Litter and Microplastics: UN system-wide contribution to support Member States in addressing marine litter and microplastics". The Task Team provided an overview of their activities, mandates, initiatives, projects and partnerships and actively participated in the exchange of information on marine litter and microplastics with the EMG Secretariat. All information was summarized and analysed in the report, that was shared with the Task Team in January 2021. The Task Team members reviewed the draft report and provided their feedback in spring 2021. The final draft report on marine litter and microplastics was shared with the Task Team for the final review in June 2021, after which (over summer period) it will be finalized, proofread, and professionally designed and laid out for publication the latest in September.

A progress report on the Task Team's work was delivered to the meeting of strengthening national plans for advancing solutions on marine litter.

Initiate targeted webinars for information exchange on marine litter and microplastics among Task Team members to continue awareness raising activities among members of the UN EMG and beyond about the importance of reducing plastics and microplastics pollution in UN facilities, operations and programming; and on specific topics of mutual interest among UN EMG members.

Establishing at the EMG Secretariat a digital inventory of UN EMG members marine litter and microplastics activities and initiatives as provided in the Report.

Task Team to serve as resource experts to support mainstreaming of plastics and microplastics reduction activities in relevant ongoing processes facilitated by UN EMG.
