## Mid-Term Progress Report

### *Note by the Secretariat*

## I. Collaboration on Global Environmental Issues

### a) Issue Management Group on Biodiversity

The first meeting was held on 15 February, in which the later finalised ToR was discussed. The Consultative Process focuses initially on addressing plastic pollution through a Core Working Group, which was established in response to the UNSG's call to unite efforts across the UN system on solutions for challenges posed by plastic pollution. The Core Working Group met on 16 March 2022 to agree on its ToR. Expected deliverables include joint messages for communication and advocacy to maximize the effectiveness of communication on plastic pollution; an overview of how the UN system and stakeholders provide sustainable solutions to the challenge of plastic pollution; a common offer to support an inclusive and just transition towards</p>	<p>The Core Working Group on Plastic Pollution is currently finalising a set of key messages on plastic pollution for the UN Secretary-General. These will be shared with the Consultative Process for comments.</p> <p>Work has started to prepare the overview of how the UN system and stakeholders provide sustainable solutions to the challenge of plastic pollution, building on the EMG report on marine litter and microplastics.</p>

A draft checklist with the aim of assisting country teams with their work has also been prepared and will be circulated to the IMG for comments.</p> <p>Strategies for engagement with the Convention on Biological Diversity (CBD) and the UN Convention to Combat Desertification (UNCCD) have been finalised.
